


## Purpose of Program

Measure water-levels around the Estancia Basin to provide groundwater trend information to the public

- Monitored from 2007 to 2010 by SNL; 2011 to 2021 by HydroResolutions.
- Contract passed to JSAI in 2021 through public bid.
- Monitored since 2021 by JSAI semi-annually, or annually depending on funding.
- Currently equipped with Bernalillo County provided transducers (n=11), checked annually (2023 and 2024).
- To be uploaded to the NM Tech's Healy Groundwater monitoring network, accessible to the public online.




## **EBWPC** monitoring well locations




#### Estancia Basin Geology

- Closed basin ~2,000 square miles.
- Alluvial thickness of up to 400 ft.
- Underlain by eastward-dipping Permian to Pennsylvanian sedimentary units (Manzano Mountains)
- Playas (salt lakes) extend from McIntosh to Willard.
- Previous studies show water-level declines of 1 to 2 ft per year; limited recharge in years of low snowmelt from the Manzanos.
- Water-level changes in three areas:
  - Stanley to Moriarty
  - McIntosh
  - Estancia to Willard (west of)

#### 14 wells

- Old domestic/irrigation/ stock wells all unequipped
- 4 likely alluvial wells
- 3 Madera (limestone) wells
- 1 Chinle Shale well
- 3 Yeso Formation wells
- 3 Abo Formation wells
- Some wells have dual completions (2 aquifers).
- All aquifers contributing to the basin are represented; except Stanley (NE basin) SAG aquifer wells


















## **EBWPC** monitoring well locations







Figure 2. Hydrographs for EBWPC-monitored alluvial or alluvium-connected wells, Santa Fe and Torrance Counties, New Mexico.

### Data explanation

- Some data series peculiarities, but overall quality is good.
- Many show fairly flat water-levels; some show seasonal variation and some consistent declines (e.g. Magnum Steel).
- Variable water-levels; rebounding water-levels with good snowpack; poor recharge water-level drops (McCoy et al., 2008). Likely young groundwater in mountainous areas.
- Overall dataset 2007 to 2024; water-level decline of 0.68 ft per year; in basin center 2.44 ft/year, some areas 4 ft/year.
- Significant decline between Estancia and Edgewood; north, west, and south of Moriarty. Data gap in Stanley area.

Summary

- JSAI took over the monitoring of wells from previous EBWPC contractor (2011-2021).
- JSAI performed 5 monitoring rounds (2021 to 2024).
- Produced a 2022 water-level monitoring summary.
- Installed 11 Bernalillo County-owned transducers in 2023; 2 were removed; 2 have since malfunctioned.
- Established data homogeneity: ready for transfer to the NM Tech's Healy groundwater monitoring network (up load this summer).
- Advertising/public awareness:





#### Recommendations

- Continued monitoring, annually or semiannually.
- Add real-time data links to select wells. Will need solar power for operation.
- Add to the monitoring network, especially in the Stanley – Moriarty area, and in the Estancia – Willard area. On a two-day monitoring round could add 2-4 more wells readily without too much additional funding.
- Additional public outreach such as this presentation.
- Continue to engage with local well owners. Thank you to all participating well owners!
