This includes the \$10,000 reimbursement for FY23 from Santa Fe County. Don Goen and Dan McGregor also noted that they would like to review that report in detail and reconcile against tracked expenses prior to accepting the report for approval, as it seems off based on last known numbers from April 2023 before the new accounting system for Torrance went into effect. A new invoice for website maintenance was also approved for

	payment and needs to be processed and is not reflected in the reported balance to date. A new MOU amendment with Santa Fe County is needed, and additional attempts to collect from Moriarity and Edgewood are also needed.

New Business:	Torrance County as Fiscal Agent item was tabled based receipt of Treasurer's report discussed under financial matters.		
	Moriarity Enterprise Bulk Terminal Water Use was discussed, and information was provided by Manny Encinas and Don Goen. Bill King disclosed that he has contractual arrangements with the facility and was providing the source water for the scheduled hydropressure testing of the tanks. The primary issue for the committee is to determine if there is a way to aid in finding a way to reuse the water (rather than just holding and evaporating). Manny Encinas to contact Carmen Connor with Audobon Company to see if they are working with NMED on discharge permit issues and to provide them with Dan McGregor's contact info. Don Goen to check with Enterprise to see if Audobon is representing Enterprise in the matter and/or status of NMED discussions. Dan McGregor to reach out to NMED contacts on behalf of the committee to identify any issues for reuse of the water and/or to see if assistance for reuse is viable or needed. End goal is to see the testing water reused rather than just evaporated.
